Mission of Agency

NYC Parks manages over 30,000 acres of the City's land. Our parks improve New Yorkers' health and quality of life, providing oases of beauty, recreation, and relaxation, particularly in communities of need. We empower people through participation and trainings, enhance the public's health from fitness classes to forests, and restore our environment's health and resiliency. Our parks connect and unify diverse constituencies through stewardship, learning and celebration, thereby strengthening and attracting investment to communities, the building blocks of our great City.

In 2023, New York City passed Local Law 12 requiring city agencies to create a five-year accessibility plan, in consultation with the MOPD.

NYC Parks is conducting accessibility audits and reworking major sections of the Parks public website, focusing on the popular events section in 2025 (underway) with further major sections to follow in 2026.

Programmatic Access

The NYC Parks Beach Wheelchair Reservation System was updated to allow beachgoers with disabilities to reserve a beach wheelchair up to 48 hours in advance on our <u>Beach Accessibility page</u>.

Workplace Inclusion

Interns from the PII (Partnership for Inclusive Interns) and AHRC NYC assisted our NYC Parks beach and pool staff over the summer months in calendar year 2024. NYC Parks aims to provide courses, training and program development opportunities to Parks staff so that they are equipped to work with those with accessibility needs and those with disabilities.

Consultations and Feedback

We've received feedback from our ADA Advisory Committee and employees regarding the creation of greater accessibility at NYC Parks. We addressed their suggestions to improve beach access for wheelchair users and those who use mobility devices with a new online beach reservation system.
